

INFORMATION CLAUSE

Dear Customers,

Since 25 May 2018 a new regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC GDPR (General Data Protection Regulation) enters into force.

Based on current personal data protection laws, in particular GDPR, in order to assure the proper protection of personal data of a natural person that natural person should be informed on a way of personal data processing on a basis of art. 13 and 14 ust.1 and ust. 2 GDPR - depending on whether if the data comes directly from that person or from other sources.

According to this obligation Jet Star International LTD Sp. z o.o. informs that:

3. Your personal data will be processed on the basis of art. 6.1 GDPR, based on the necessity of personal data processing for purposes resulting from legally justified interests of Jet Star International LTD Sp. z o.o.;



4. Legally justified actions implemented by Jet Star International LTD Sp z o.o. consist on offering to it's clients products and services, which contribute to the increase of stability and security of the business trading;
5. Your personal data will be processed by our employees and also in an automated manner;
6. The controller processes only your personal data that is already shared by public sources p.ex. The Register of Entrepreneurs of The National Court Register (KRS), The Central Evidation and Information on Business (CEiDG);
7. Your personal data will be retained for the duration of the cooperation and till it's end, for the duration of the possibility of concluding such agreements and for the duration of the legal consequences of these agreements and in order to assess and pursue claims under these agreements;
8. The recipients of your personal data will be those entities to whom we are required to provide data in accordance with applicable law, including tax offices, and entities providing IT, accounting, legal, transport, courier, postal services, etc., and other entities to which we will outsource the data processing.
9. In case of a delivery request to a third country, your personal data might be transferred to the third country and the fact of placing order as such is treated as a consent to this specific data transfer. Detailed information in this regard and concerning the level of data protection at our service providers in third countries can be requested from the contact information specified under Item 1.
10. We will keep your personal data for as long as it remains necessary for the realisation of the order and for all aftersale services such as a guarantee or a return.
11. The controller makes every effort to provide all means of physical, technical and organisational protection for your personal data against accidental or intentional destruction, accidental loss, change, unauthorised disclosure, use or access, in accordance with all applicable regulations.;



12. Concerning the processing of your personal data you have the right:

- to request an access to the content of your data,
- to request to rectify your personal data,
- to request to delete your personal data,
- to request to limit the processing of your personal data,
- to object to the processing of your personal data,
- to data portability,
- to lodge a complaint with the Inspector General for Personal Data Protection;
